Product Discontinuation Announcement – Lumberg Automation M12 Power “SW”

Dear Valued Customer,

This letter serves as formal notification that Belden will discontinue the select **Lumberg Automation M12 Power products** identified in this notice, effective December 31, 2026.

This decision follows a comprehensive review of our product portfolio and is part of an ongoing initiative to streamline our offerings by reducing product overlap and eliminating duplicate variants. These changes enable us to provide a more focused and efficient product portfolio while continuing to support our customers' application needs.

The products being discontinued are those with the "SW" suffix in the product description. Historically, the "SW" designation identified products manufactured with black overmold, while customers also had the option to purchase equivalent products with blue overmold. Moving forward, Belden will standardize black overmold material for all M12 Power products. As a result, the separate "SW" product variants are no longer required and will be discontinued.

Please note that the recommended replacement products are direct replacements and are fully interchangeable with the discontinued products. There are no changes to fit, form, function, performance or aesthetic appearance. As a result, no modifications to existing installations or applications are required.

Belden's standard warranty terms will apply to all products delivered on or before the final delivery date.
